Waste Management Policy

The institute has a duty to ensure that all campus waste is disposed of properly by using proper waste segregation mechanism at the source and if possible, converting it into value added environment friendly products.

Purpose

- To ensure proper disposal of waste from activities conducted by or overseen by facilities management staff.
- To minimize waste generation at source and facilitate repair, reuse and recycling over the disposal of waste in a cost-effective manner.
- To provide appropriate training for teaching, non-teaching staff and students on waste management issues to promote holistic approach of waste management in the college campus.

Scope

This policy will be applied to all waste disposal activities by facilities management staff or contractor working for facilities management and to all the employees and students of Dr. S. Radhakrishnan College of Education.

Procedure

Solid Waste Management

- Institute will apply a waste hierarchical approach to reduce, reuse and recover waste products.
- Solid Waste at the canteen, classroom, Office and Campus will be segregated at source using green, red and blue dustbins. Paper and other degradable wastes is collected in blue dustbin. Metals, e-waste organic waste is collected in green dustbin and non-degradable wastes is collected in red dustbin.
- Concerned Staff will put off the waste in the nearest dustbin and close its lid.
- Cardboard should be flat and placed next to any recycling receptacle.
